# Call to Order

# Action Items

- Authorizing Resolution: Admirals Cove II
  - S. Porath introduced the project, which involves a request by Admirals Cove for additional sales tax exemption associated with the construction of the project, as well as authorization to amend the existing PILOT to reflect the construction of a restaurant at the site. He noted that a public hearing had been held and there was no public comment.
  - A motion to approve the resolution was made by T. Riley, seconded by R. Amar. All in favor. Motion passed, 3-0.

- Inducement Resolution: Aptar Group, Inc.
  - S. Porath introduced the project, Aptar Group, Inc., which involves the applicant seeking sales tax exemption as part of an expansion of its operation in Congers, Town of Clarkstown.
  - Aurelien Paumier, representing Aptar, presented an overview of the project and answered questions from board members.
  - With no further questions, a motion to approve the inducement resolution was made by T. Riley, seconded by R. Amar. All in favor. Motion passed, 3-0.
- Inducement/Authorizing Resolution: Natixis
  - S. Porath introduced the project, Natixis, which involves their request for sales tax exemption for equipment as part of a datacenter located in Orangeburg, NY.
  - Kate Wenger, representing Natixis, presented the scope of the project and answered questions from board members.
  - With no further questions, a motion to approve the inducement was made by R. Amar, seconded by T. Riley. All in favor. Motion passed, 3-0.
- Inducement Resolution: Spring Valley Marketplace
  - S. Porath introduced the project, which involves the renovation and expansion of a retail shopping center into a mixed retail/office use facility. The applicant is seeking sales and mortgage tax exemption, as well as a PILOT.
  - Hershey Friedman, representing the applicant, provided further details of the project and answered a variety of questions from the board. In responding to questions, Mr. Friedman indicated that the project – as presented – will require IDA incentives.
  - Following a various questions from the board, the board tabled a decision on the matter subject to further discussion.
- Resolution PARIS Submission Authorization
  - Board members considered an annual resolution authorizing the submission of the New York State compliance PARIS report and related documentation (once complete)
  - A motion to approve the resolution was made by T. Riley, seconded by R. Amar. All in favor. Motion passed, 3-0.

# New Business

- Discussion: Transit-Oriented Development
  - Representatives of a proposed transit-oriented housing development project presented an overview in relation to their request for the Agency to consider the eligibility of the project for financial incentives.
  - Following a number of questions and other discussion items, the board agreed to further discuss the matter at a following board meeting.
