#### Action Items

- Authorizing Resolution: Connectivity
  - S. Porath provided an overview of the project, which involves the expansion/construction of a facility in Monsey, NY.
  - He noted that a public hearing had been held and there was no public comment.

- With no further discussion, a motion to authorize the project was made by T.
   Riley, seconded by M. Geller. All in favor. Motion passed, 3-0.
- Authorizing Resolution: Rt 59 LLC Sales Tax Exemption Extension
  - S. Porath introduced the matter, which involves extending the termination date for sales tax exemption previously approved. He noted that the project had unexpectedly experienced delays in municipal approvals and construction.
  - With no further discussion, a motion to authorize the matter was made by R.
     Amar, seconded by M. Geller. All in favor. Motion passed, 3-0.
- Authorizing Resolution: Jawonio Partnership
  - Members discussed the proposed limited partnership with Jawonio Inc. to advance workforce development.
  - o Following discussion, a motion was made by T. Riley, seconded by M. Geller, to authorize entering into the agreement. All in favor. Motion passed, 3-0.
