Noting that sufficient advance public notice had been given and there being a quorum present, the regular meeting of the Rockland County Industrial Development Agency was called to order at 11:10 a.m. by Chair T. Riley

<u>Call to Order</u> T. Riley

Action Items

- Inducement Resolution: GDC NRCSD PILOT
 - The project has been withdrawn by the applicant and the matter was tabled.
- Inducement Resolution: Tower Research Capital
 - S. Porath introduced the project, which involves the applicant's retention/expansion at datacenters located in Palisades and Orangeburg. The applicant is requesting sales tax exemption on \$150 million in equipment.
 - Representatives of the company provided a more detailed overview of the proposed project and answered a variety of questions from board members.

- The company particularly noted the competitive nature of the project and that the IDA incentives are the key factor in locating the project in Rockland County.
- o Following discussion, a motion to approve the inducement resolution was made by R. Amar, seconded by M. Geller. All in favor. Motion passed, 4-0.
- Local Labor Policy Amendment
 - S. Porath introduced the matter which involves amending the Agency's local labor. The amendment requires projects to maintain a binder that provides all worker details (names, addresses, etc.) during the duration of the construction process.
 - Following discussion, a motion to approve the amendment was made by T. Riley, seconded by P. Zugibe. All in favor. Motion passed, 4-0.
