

**TERMINATION RESOLUTION  
COUNTY OF ROCKLAND INDUSTRIAL DEVELOPMENT AGENCY  
WITH  
ASSISTED LIVING AT NORTHERN RIVERVIEW INC.**

WHEREAS, the County of Rockland Industrial Development Agency (the "Agency") is authorized under the laws of the State of New York, and in particular under the provisions of the New York State Industrial Development Agency Act and the Agency's enabling legislation, respectively constituting Article 18A and Section 925-1 of the General Municipal Law (Chapter 24 of the Consolidated Laws of New York), as amended (the "Act"), to assist in providing civic facilities for the use or benefit of the general public; and

WHEREAS, the Agency previously entered into a transaction as of February 1, 1999 with Assisted Living at Northern Riverview, Inc. (the "Company") in connection with the property located at 87 South Route 9 W, Haverstraw, New York (the "Premises") to be utilized as an assisted living facility (the "Project"); and

WHEREAS, as part of that transaction, the Agency acquired a fee interest in the Premises by a Bargain and Sale Deed dated December 27, 1999 from Normet Holding Corporation to the Agency, which was duly recorded in the Rockland County Clerk's Office on February 24, 2000, as Instrument No. 2000-00007957; and

WHEREAS, as part of these transactions, the Agency and the Company entered into a certain Lease Agreement ("Lease Agreement"), the PILOT Agreement, and other related documents (the "Project Documents") as of December 27, 1999; and

WHEREAS, the benefits received by the Company for the Project consisted of a PILOT Agreement; and

WHEREAS, the Company has for more than twenty-two years, otherwise complied with all of the terms, covenants and conditions of the Project Documents; and

WHEREAS, the Company has now applied for a new PILOT Agreement and has requested that the Agency terminate the prior Project in accordance with the terms thereof; and

WHEREAS, the Agency and the Company now desire the Agency to reconvey the Premises by Quit Claim Deed, terminate the Lease Agreement, the PILOT Agreement, and other Project Documents, and the Company has requested that the Agency waive its rights to seek a recapture of any of the benefits provided to the Company.

NOW, THEREFORE, in consideration of the foregoing the Agency, after due consideration and taking into account the circumstances, resolves as follows:

1. The Agency agrees to terminate this Project and also to waive its right for a recapture of any of the benefits the Company received. The Company has created new employment positions and has otherwise complied with all of the other terms, covenants, and conditions of the PILOT Agreement and the Project Documents and has constructed the improvements to the Premises as described in its application.
2. The Memorandum of Lease between County of Rockland Industrial Development and Assisted Living at Northern Riverview, Inc. and the Memorandum of Lease between Normet Holding Corporation and the County of Rockland Industrial Development Agency shall be terminated.
3. Any authorized representative of the Agency is authorized to and shall, terminate all of the Project Documents and is also hereby authorized to reconvey the Premises by Quit Claim Deed, terminate the Lease Agreement, the Memorandum of Lease, the PILOT Agreement and other Project Documents.
4. Any Authorized Representative of the Agency is hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required or provided for in connection with the execution of all termination documents and to do all such further acts and things as may be necessary, or in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of this resolution.
5. The Chairman, any member of the Board of Directors, and the Executive Director of the Agency (as used in this resolution, the "Authorized Representatives") are each hereby authorized and directed to execute and deliver all termination documents with respect to the property comprising the Project in such form as deemed reasonable or necessary.
6. Any expenses incurred by the Agency with respect to the Project and the financing thereof, including attorney's fees and disbursements, shall be reimbursed by the Applicant. By acceptance hereof, the Applicant agrees to pay such expenses and further agrees to indemnify the Agency, its members, employees and agents and hold the Agency and such persons harmless against claims for losses, damage or injury or any expenses or damages, including attorney's fees and disbursements, incurred as a result of action taken by or on behalf of the Agency in good faith with respect to the Project and the financing thereof.
7. Capitalized terms used herein, which are not otherwise defined in this resolution shall have the meanings provided in the Project Documents.
